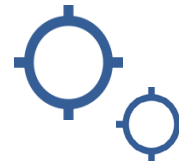
Set up & capture entire crime or crash scene 360 degree photos in under 20 minutes.

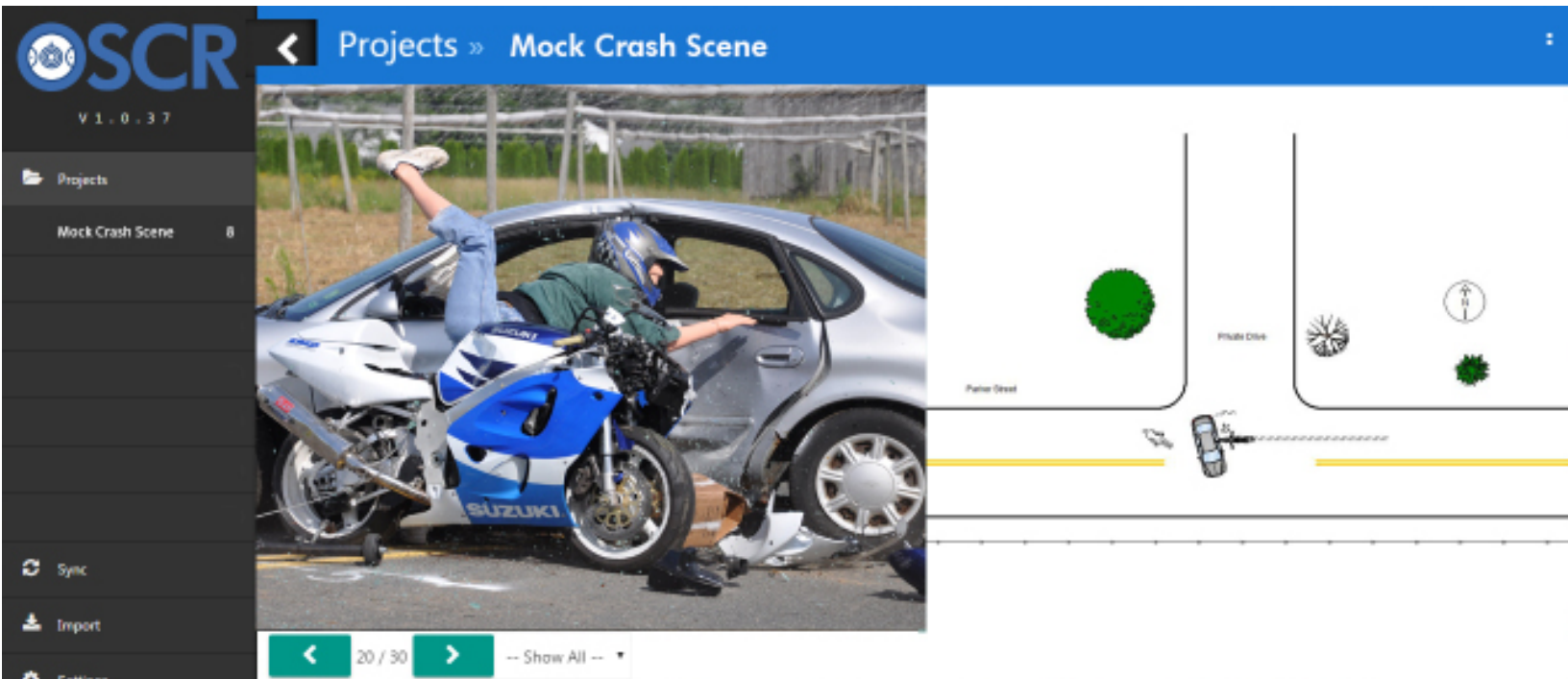
